Terms and Conditions

In order for this membership application to be processed by Archery Guyana Inc. the following shall apply:

- This form must be completed by applicants and submitted to the Secretary.
- All required fields on this form are to be completed legibly and as required by the headings.

The names of the prospective members shall be circulated to the general membership of Archery Guyana. Should there be no objections within 21 days, the prospective members shall be called in at a specific time for an interview. Thereafter, provisional membership shall be decided upon by a vote of the Archery Guyana's Board.

Any applicant rejected for membership cannot be proposed again until a period of one year has elapsed, starting from date recorded on this form that the Organisation received same.

Annual Subscription / Affiliation Fees

There shall be an annual subscription fee, due on the 1st day of January of each year in the sum of \$10,000. Or as fixed from time to time by the Board. Any member or affiliated organisation whose annual fees have not been received by the Treasurer on or before the 28th of February before AGM for that year will automatically forfeit membership or affiliation and shall only be re-admitted to membership or affiliation upon payment of one year's subscription or affiliation fee and a penalty of 50% of the annual fee. Fees forfeited for in excess of 2 successive years without the consent of the Board shall require complete reapplication to the Organisation.

Group Membership

Any Archery Club wishing to associate with Archery Guyana shall address itself to the Secretary and provide whatever information it may deem necessary. On notification of acceptance for affiliation, the Club shall forward to the Treasurer, the appropriate and current affiliation fees.

Important Note

Only financial members will be given an ID Card to be presented to the Head Coach or any other Official on the shooting range. Members must have this in their possession at all times or will not be permitted to shoot.
